#### Challenge

Numarics is currently executing a buy-and-build strategy within the Swiss accounting, tax and audit market and has been acquiring several small- to medium-sized accounting firms in the last few years. At the same time, Numarics has invested substantial funds in the further development of its AI driven business administration software. So far, the company has been fully equity financed and is backed by major international VC funds.

While still a start-up, Numarics is looking for non-dilutive funding solutions to finance their ambitious inorganic growth plan. *"We have a stable and cash flow positive accounting business that we want to leverage. This will allow us to realise our growth strategy, extend our runway and ultimately increase our valuation"*, says Dominique Rey, CEO and Co-Founder of Numarics.

Given the inherent VC risks and the current market environment, the goal of arranging a bank financing was a real challenge.
